

COMMUNIQUE

MCB Group Limited (“**MCBG**”) wishes to inform its shareholders and the investing public in general that, following the offering of 922,476 options to employees under the Group Employee Share Option Scheme in October 2024, a total of 49,036 options were exercised for a total consideration of Rs. 23,046,920.00 during the last transfer window of the scheme. The balance of 583,402 options which were not exercised during the year have now lapsed.

As a result of the above, 49,036 new Ordinary Shares have been issued on 28th October 2025 by MCBG for listing on the Stock Exchange of Mauritius Ltd. The number of Ordinary Shares in issue now stands at 261,583,791.

Furthermore, MCBG has, in accordance with the terms of the GESOS, offered 882,729 options to employees of the group in respect of the financial year ended 30th June 2025, which will be exercisable in four distinct windows.
